I have examined the accounts and financial records of the Information Systems Audit and Control Association, Minnesota Chapter for the year ending May 31, 2005. In my opinion, the accounts and financial records for the year ending May 31, 2005 show a true and fair view, in all material respects, and the accounts and financial records of the Chapter have been properly kept during the period under review in terms of the Constitution of the Chapter, resolutions of Directors and members, and generally accepted accounting principles.
